# Forest of Dean Resident disqualified from keeping dogs

I am sure you will be pleased to hear that the District Council views dog cruelty seriously and recently had a successful prosecution against a Forest of Dean Resident found guilty for animal cruelty. Veterinary reports confirmed that the dog, Maisie was underweight for a dog of her size and breed and with blood tests confirming that there was no medical cause for the weight loss. The only conclusion to be drawn that it was from starvation. The sores on her body were thought to be caused by the bars of her cage, which she was confined to when the owner was out of the house.

The resident was disqualified indefinitely from keeping or looking after dogs and ordered to pay £330 in fines and costs after being found guilty of causing unnecessary suffering to the Staffordshire terrier Labrador cross.

Maisie has now made a full recovery and is currently looking for a forever home.

#### Church on the Street Memory Café

Church on the Street Volunteers have recently launched a memory café after attending a dementia awareness session delivered by one of the District Council's dementia Friendly Community Enablers. The awareness session helped the Church on the Street volunteers to realise that they had the skills, knowledge and connections to support residents living with dementia and memory loss. The Memory Café is held once a month in the Church on the Street shop in St. John's Street in Coleford. The café provides a safe venue where people with dementia and their carers can relax and chat with other like-minded people whilst enjoying refreshments.

#### Love your Forest - Trash Converter

The Trash Converter was recently at the Activities Festival at Speech House. Once again they have lots of events planned during the summer highlighting the problems of litter. More details of events will be announced shortly.

I would also like to take this opportunity to thank Marion Flynn and her many helpers from Staunton who took part in clearing litter in and round the village. Our village certainly looks so much better.

#### Dog Poo

I recently had a complaint that a dog walker was disposing bagged dog poo in a resident's residual Bin. I advised the resident to put a notice on her bin and if it's happening to anyone else please do the same. I have spoken to the Council and very little they can do about this, but I have asked Street Wardens to paint a stencil on the pavements.

#### 2213 PLANNING APPLICATION P0446/18/FUL

A member of the public attended to outline his concerns about this planning application. Councillors resolved to submit the following comments to the planning team.

- 1) The proposed car parking spaces are not large enough for each car only 2.4 as opposed to 2.5 which is the minimum car parking space provided by legislation. The car park, therefore, will not accommodate 8 cars meaning that a number of cars will be parked in the road obstructing access to neighbours drives.
- 2) There will be no access for emergency vehicles
- There is insufficient space for vehicles to manoeuvre and leave the spaces in forward gear as requested by Gloucester County Council's requirements
- 4) The new proposal does not address the ongoing problems that were raised initially
- At this stage, the home is not fully occupied and when it is fully occupied the current problems will be exacerbated
