## Staunton Parish Council Report District Councillor Report

#### New Hospital in the Forest of Dean

I am sure most of you will have seen in the Press that the Citizens Jury have now met and made a recommendation on the site of the New Hospital in the Forest of Dean. Although the vote was close their preferred option is Cinderford.

Both Hospital Boards, the Clinical Commissioning Group and Glos Care Services, have now met to confirm the final decision.

#### Pest Control Service to be discontinued

Cabinet have now confirmed that the Pest Control Service offered by the Council will cease on the 31 March 2019. They have however agreed to set up a fund of £8,000 to be drawn on when necessary for those residents in most need. The fund will be managed by the Environment Regulatory Service Team who will be able to monitor need and will be used to avoid enforcement action if the resident is in receipt of benefits.

#### **Chalets at Kiln Cottage**

I confirm that this development has been reported to the Council and I have talked with the Enforcement Officer who confirms that it is being investigated.

#### Visit to Stowfield Quarry

Following the invitation from the Quarry Manager to view a blasting shot from the viewing Platform on the 4 September, I confirm that I was present, along with John Rogers, Cllrs Terry Hale and Carole Allaway Martin and Andy Birchley Environment Officer from Gloucestershire County Council. The invitation was also extended to Staunton Parish Council and other interested parties as a result of recent meetings of the Stowfield Liaison Committee. Nick Bainton, Chief Environment Officer from Glos C.C. was also present in the Village when the shot went off.

Watching the shot go off from the viewing platform was impressive and the care that the Quarry take on health and safety grounds before the shot goes off. However there was a complaint from the village.

The shot fired was a normal shot, 3 levels down in the Quarry, and out of the 3 seismographs that were deployed only one triggered which was at Kiln Cottage and had a reading of 1.91m/s and an air over pressure reading of 100db which confirms the shot was well within permitted consent and in line with normal readings. The 2 seismographs that did not trigger were at 2 Whippingtons and the Bungalow at Crossways.

# **Sheep Complaints in Staunton**

There have been several complaints about wandering sheep in Staunton. The best way to report such incidents is to phone the Forestry Commission on 0300 067 4800 where all such calls are logged.

I spoke to Cllr Terry Hale who is on the Sheep Liaison Committee where such complaints are discussed. He also contacted Mick Holder from Commoners Association, the Police and Trading Standards. The sheep in question were then lifted from Staunton.

The Village Hall brought the paperwork for the planning permission for the windows and a cheque for £117 was approved by Council for this which will be reimbursed by the Village Hall.

## b. Annual returns 2017/2018

The new accounts were presented to the auditor but due to confusion around the new system this year this needs to be redone at the next meeting since Staunton Coleford have a turnover less than £25,000 so can exempt themselves and save £200. Council approved that it would make itself exempt from a full audit.

## 2293 QUARTERLY RISK ASSESSMENTS

Council need to carry out risk assessments of areas on a quarterly basis. The bench on The Butts that was falling apart has been removed by John Richards and the notice board on The Pound was fixed. Council thanked John Richards for this work.

# 2294 HOW TO MAKE THE WEBSITE MORE USER FRIENDLY

The clerk reported that the website is difficult to maintain.

#### 2295 STAUNTON MEEND

John Flynn attended the meeting for this item and explained that he had asked Gloucester Trust to take over the management of the Meend since the task is onerous for volunteers and wanted to arrange for a successor to take over the management. Council will be meeting with Gloucester Wildlife trust. A member of the public asked why the bracken had not been treated this year and John explained that the contractors' machinery broke down in the middle of the work. A member of the public asked for the financial records to be made available.

2296 ROAD SAFETY

John Flynn is still working on this project and explained that his primary objective is to get the police to attend more regularly. JH tried the find out about the number of groups using the route for Duke of Edinburgh expeditions but this information is not readily available.

JS to email constabulary details to Clerk who will email them to say that Council will form a team to use the speed gun on the road.

Clerk to write to Police Commissioner requesting his assistance with implementing further policing activities of the 30 mph limit through the village.
