All posts have been restored temporarily. On the top road cattle grid, the gate posts have been dug out and refitted and fencing has been replaced. Fencing has been fixed around Cheryl's land.

Council resolved to pay £400 towards making the ash tree safe in advance since Council is not meeting in August 2019 and it is anticipated that the work should be completed before the meeting in September 2019.
