2890 MINUTES OF PREVIOUS MEETING HELD 6 JULY 2021

It was **resolved** to approve the minutes of the meeting; they were signed by the Chairman.

2891 CLERKS REPORT

- 2891.1 It was reported that the Planning Inspectorate had raised a couple of minor issues with the application for The Meend; these had been resolved but a further 28 days were required for consultation responses.
- 2891.2 Thanks were offered to Cllr Sadler for completing the Annual Census of Agriculture.
- 2891.3 It was noted that highways issues raised at the previous meeting had been reported but that no acknowledgement or response had been received.

2892 MATTERS ARISING

- 2892.1 re minute 2870.1: it was reported that Mr John Richards had, with the help of couple of residents, constructed and erected a new notice board on The Pound. A letter of thanks had been sent.
- 2892.2 re minute 2877.3: it was reported that Roberts Construction had been instructed to proceed with the work on the Meend road to a maximum cost of £5500. It was understood the work would take place in September / October.
- 2892.3 re minute 2879.3: it was agreed simply to monitor the condition of the Ash trees near Kiln Cottage.
- 2892.4 re minute 2883.4: it was reported that no reply had been received from Community Speed Watch Team to the enquiry about training for the speed gun. (See minute 2895, 1st bullet point)

2893 STAUNTON CHURCH

Denise Hogan, minister of Staunton Church was allowed to address the meeting. She explained that major work was needed to be undertaken to the fabric of the church at a total estimated cost of £750k and she was seeking support from the Parish Council, both financial and practical. The Clerk advised that the Local Government Act 1894 s.8(1)(i) prohibits Parish Councils making any financial contribution to the upkeep of churches; nevertheless members offered non-financial help and support and suggested notices be placed in the village and on Facebook to encourage residents to get involved.

Cllr Allaway-Martin reported:

- Speed gun training may be arranged now from Coleford Police Station.

- GCC considering 20 mph traffic orders Staunton Parish Council could present a case to the scrutiny meeting.
- 'Build Back Fund' £40k over 4 years with Staunton's share being £12k. Criteria stil to be advised but likely to focus on sustainability and community effort.

- Proposed new GP hub in Coleford to replace two existing practices; likely to be 3 years subject to planning permission.

2901 PARISH LAND

- 2901.1 It was reported that Cllr Richard had replaced the stone slabs at Brindsey Well
- 2901.2 It was reported that work had commenced on Ash trees and that the commoner had been advised
- 2901.3 It was reported that there was an issue with dog waste on The Meend. Initially it was agreed to obtain some 'flick it' signs to fix to gates and if that did not improve the situation to erect a couple of purpose made dog waste bins at strategic points.
- 2901.4 it was reported that an approach had been made by Jamie's Farm in Upper Redbrook about grazing cattle of the Meend. The farm manager would be invited to the next meeting to discuss.
- 2901.5 Concern over recent bracken rolling had been allayed when it was discovered that the owner of Birchenwood Cottage Mr Michael Bryant had done this work on his own initiative. Cllr Richards had met with Mr Bryant and learned that he is keen to help with management of the land. It was agreed that a discussion was needed over the issue of public liability insurance and liaison with the Parish Council over work to be undertaken.

2903 DEFIBRILLATOR

It was reported that a new defibrillator was on order with delivery expected any day. The full net cost (after part exchanging usable items from the old machine) had been covered by a grant from the Village Hall Committee.
