# **Chairman's Annual Report May 2022**

### **Grants**

During last year we received a request from The Alms-house Committee to provide a grant to supply water to the land adjacent to the Alms-house's that they wished to develop into allotments. The PC were happy to grant this and a water supply has been provided for the allotment project. I believe that there is space for three patches and these have been allocated to residents of the village.

### **Highways**

# VAS ... continuing saga.

Sadly this project is an ongoing challenge for us, but we may just be coming to a conclusion. GCC have been changing the goalposts for us over the last year and we have had to provide old data as if we were applying for 'new' signs. They seem to fail to understand that all we are asking for is 'replacement' signs and not 'new'. However, we have asked for two sets of solar powered signs at each end of the village rather than one VAS that had to be moved manually. We are hopeful that these new solar powered signs will be funded by GCC and not from PC funds. Hoping for resolution soon on this one as it has been running for a long time now.

### **Road Markings**

After many months of waiting the rumble strips, dragon's teeth and road marking have been repainted.

# **Rookery Lane**

Although Rookery Lane is a 'restricted byway' and therefore there is no requirement to maintain it to highways standards, Highways have agreed to fill any reported potholes when there is 'end-of-day' material available. Also, after many discussions, they have improved the signage on the lane. This continues as work in progress.

### The Meend

The road from Meend Cottage to The Cabin was in a fairly bad state of repair and as it is owned by the Parish we are responsible for it. The Parish Council decided that resurfacing was required. We were fortunate to be able to obtain some, but not all, asphalt supplies from Tarmac, Stowfield free of charge, which certainly helped with the final invoice.

The Land Management of The Meend continues to be a challenge and although we have obtained an extension from DEFRA HLS scheme until April 2023, we are still awaiting our annual payment from Rural Payments Agency for the 2021. This appears to be due to an administrative error on their part. We continue to communicate with them to receive our payment.

The main challenge on the Meend is controlling the bracken and as such we have been in negotiation with Jamie's Farm, Redbrook, with a view to them positioning cattle on the Meend to try and control bracken and improve the soil to allow for more wildlife/flowers to flourish.

### **Trees on Parish Land**

Over the last couple of years we have spent considerable amounts of money from the Precept to ensure that trees in the Parish are well maintained and made safe. Sadly, some have had to be felled, but others pruned back to avoid any dangers. The main areas that have received work are:

- Castle Ditch- (ongoing)
- The Butts
- Land adjacent to The Cabin

### Defibrillator

Our previous defibrillator was becoming quite old and finally gave up some time ago. The Village Hall Committee kindly offered to pay for a replacement newer version that was fitted during October 2021.

# **Footpaths Group**

One of our newer Cllrs has set up a Footpath Group and has been busy checking the 28 footpaths in the Parish. He has also been in contact with GCC Rights of Way Officer who has become involved and helped with arranging repair/replacement to some gates/stiles in the Parish.

Dog fouling continues to be a challenge for us, so we have recently ordered new Dog Waste signs that will be appropriately placed around the village.

# **Brindsey Well Pump**

Many of you may remember that there was a Millennium Project to re-instate the original pump that was excavated from Brindsey Well. I am very pleased to report to you that the Parish Council have taken this on board and the pump will be positioned next to Brindsey Well as soon as possible with an information plaque.

### Volunteering

Whilst we very much appreciate villagers wishing to improve some of the landmarks in the village, any work will have to be done at your own risk as our insurance does not cover us for any other kind of work. However, we very much appreciate the involvement of villagers who cleared The Pound recently.

### **Jubilee Celebrations**

At present the Parish Council are hoping to plant a tree for each of the children in the village under the Jubilee Green Canopy project. As the season has just passed, we are expecting to proceed with this project in the autumn. We will continue to communicate plans through PC Meeting minutes and the Village Facebook page.

# **Thank you Councillors**

I would like to take this opportunity to thank all of the Parish Cllrs and the Clerk for their support and enthusiasm over the last year and previous years. We have been blessed with a wealth of knowledge and experience that is very much appreciated at this level of local government. As always, if any villagers are interested in joining the team, we are happy to discuss with you what is involved and how rewarding it is to maintain and improve our lovely village.





### REPORT FOR ANNUAL PARISH MEETING

Income for the year was up by 16% due to a significant increase in the precept of 40% and other income (primarily a grant from the Village Hall committee to fund the new defibrillator), but offset by the non-receipt of the anticipated Meend grant of £1156, which we are still hoping to receive.


Expenditure changes to note are –

- staff costs down by 20% due a change in salary payment dates there were only 3 such payments during the period.
- admin costs down 41% due to exceptional costs for IT the previous year and a significant reduction in the insurance premium following the responsibility for insuring the village hall being removed from the Parish Council.
- Community costs were up 75% following Meend road repairs of £7000 and tree work.

Overall expenditure was up 61% (a similar sum to the previous year's increase) to £19145 which resulted in an overspend during the year of £3091.

The closing balance has reduced to £19881 and has been apportioned to various specific reserves, leaving just £5631 as a 'free' reserve. With the strong likelihood of major expenditure in future years on further tree work and some uncertainty over the continuing grant for the Meend, the decision was taken to increase the precept for 2022/23 to £15000.

The Parish Council acknowledges that there has been a significant increase in the precept over the three years from 2020/21 to 2022/23 of 75%, but management of around 50 acres of Common Land and all the other small areas of land – with their numerous trees – cannot be properly managed on a shoestring. In fact, had the precept remained unaltered we would now have dangerously low reserves to meet unexpected expenditure. The graph below shows levels of income, expenditure and precept over the last 14 years.
