3338 CLERK'S REPORT.

3338.1 The Clerk read emails from the correspondence made on the suitability of the VAS equipment. It was reported that the costs to upgrade the machines with solar panels would be within the high hundreds of pounds range, however, it was

mentioned that the panels only prolong the life of the batteries and do not make the machines self sufficient.

3338.2 Cllr Wheeler addressed the observation that other Parishes had two machines, saying that they must remain mobile.

3338.3 There are also residual build back better funds from county councillor Martin if the Council wished to either purchase a new VAS machine or upgrade the current one. Any new addition to the asset list would also require an update to the council's insurance policy.

3338.4 Regarding the bins and the grit. The Clerk was instructed to chase this timeline up as the actual delivery had been promised before last Christmas.

3338.5 The matter of the Council's previous enquiries with highways over the potential purchase of some of its land for use as a car park, was reported to have never been recorded by Highways, meaning that they were oblivious to this request. A new, more formal enquiry letter would need to be drafted to reinitiate this.

3338.6 Tarmac has been approached for a potential meeting over the quarry blasting. The management here were open to a meeting, and discussion was had on what was the best date to hold this. A tentative date of September 11th was suggested and this would be proposed to the Tarmac management and Nick Bainton at GCC.

3338.7 Highways needs to be made aware of an overgrowth of weeds on the pavement by the church wall.

3338.8 The Clerk presented a template for the recruitment and co-opting of a new Councillor. The Council approved this document and will circulate it through the Council's media.

3339 PUBLIC QUESTIONS.

3339.1 A complaint was heard regarding the lack of carparking space for the village pub. It was suggested that a finger sign or similar to the village hall overflow car park would assist in reducing obstructive parking in the village. A sign to serve as directions to the village hall carpark as a overflow carpark was suggested. This needs to be requested of the village hall management committee. The planning application stated that 'no building wok shall commence on site on the dwelling proposed until the alterations to the car parking for the White Horse Inn, including demarcation of spaces have been implemented in accordance with the submitted plan and shall be similarly maintained thereafter. The Clerk will investigate the original planning application documents and report back. Notice of the overflow site could also be put up on the council's Facebook page.
